# Minutes May 10, 2023

The regular meeting of the Alexandria Lake Area Sanitary District Board was held May 10, 2023, at the ALASD Maintenance Building located at 2201 Nevada Street, Alexandria, Minnesota.

The Board of Directors meeting was called to order by Chairman Thalman at 5:30 P.M.

## **Presentations and Reports:**

- Chairman Thalman called upon Plant Superintendent Troy Drewes. Drewes's report included: Completed hauling biosolids, investigated main lift station pump plugging issues with vendor, quotes for aging chiller, annual lake sampling began, spring maintenance on roof exhaust fans, repairing auto drain on air compressor, and finally general maintenance.
- Chairman Thalman called upon Collection System Superintendent Brad Timm. Timm's
  report included: quarterly jetting of trouble spots, E-one residential stations CR-3, CR-5 and
  CR-6 were upgraded, repaired leaking discharge plumbing at LGS-17 while ALASD staff
  replaced plumbing with stainless steel, and moved the control panel, started root cutting &
  jetting in the city of Alex, and finally residential grinders spring inspections were started.
- Chairman Thalman called upon Engineer Bryan Bye. Bye's report included updates on the 18<sup>th</sup> Avenue Project, LS 73/Forcemain project, Roundabout(s)- I-94/TH 27 and Co. Rd 82/45 Karl Drive, Grinder Station LGS57/Forcemain Improvements, ALASR study areas, LS1 Forcemain Improvements, and GIS upgrades.

Executive Director Gilbertson presented the Board with financing options for future sewer projects and capital projects, including a memo from Gail Robertson, Municipal Advisor from Government Capital Securities.

Executive Director Gilbertson, Plant Superintendent Drewes and HR Bergs informed the Board of two Public Education Efforts attended by staff: Earth Day on April 22, 2023, and the 30<sup>th</sup> Annual Kids Water Festival on May 3, 2023.

Executive Director Gilbertson informed the Board that he will be presenting at the 96<sup>th</sup> Annual CSWEA meeting in St. Paul, MN, being held May 29-31st.

# Special Project Updates/Regulation Updates:

Executive Director Gilbertson informed the Board about the ALASD adding rip rap to the Carp Barrier to ensure the rock barrier is the correct elevation during peak high-water conditions.
