Clean water is critical for the health of the communities & the natural environment in the Alexandria Lake Area. Improvements to ALASD Water Reclamation Facility (WRF) are needed to meet State of Minnesota permit requirements for nutrient reductions & protect water quality while protecting the regional economy to accommodate existing & continued growth.

## Protect the sensitive waters of the Alexandria Lakes Area

#### **OUR ASK**

ALASD requests \$25 million to upgrade Alexandria WRF, which serves 3 cities and 8 townships. This \$70 million project will include advanced ultrafiltration technology to remove significant amounts of phosphorus and protect the Lake Winona-Agnes-Henry-Le Homme Dieu-Carlos chain of lakes, and the Long Prairie River watershed.

#### **Environmental Protection**

When nutrients such as phosphorus and nitrogen enter surface waters, it can lead to algae which is linked to fish kills and toxic algae blooms. The WRF upgrade will significantly reduce phosphorus and nitrogen to protect lake health and overall ecology.

# Support More Affordable & Multi-family Housing

Population growth in the Alexandria area has increased the need for more affordable and multi-family housing, which will require additional capacity in ALASD's infrastructure. ALASD serves a population of 26,500 that continues to grow.

ALASD has been a state leader in reducing nutrients in Minnesota's waters. With this project, phosphorus and nitrogen will be among lowest in state.

#### **Affordability Concerns**

Estimated costs for facility improvements exceed \$70 million, with over half attributed to meeting nutrient reduction requirements. ALASD has incrementally increased user rates 10% each year over the past three years, but additional funding is necessary to maintain affordability while meeting state standards.

#### **Regional Impacts**

The advancements to the WRF will improve water quality, safeguarding the environment and supporting the regional economy. Protecting water quality preserves the region's property values while fostering growth for businesses, tourism, and industry.

Legislative support is essential to facilitate necessary infrastructure upgrades & protect the region's water resources for generations to come.
